Arlington Business Man Was Active In Community Affairs

Funeral services were held Wednesday afternoon for H. C. McClellan, long-time Arlington business man and community worker. He had died at his home Sunday at the age of 84.

Mr. McClellan was born at Salem, Indiana January 17, 1883 but

He had held an active interest in numerous community activities. For a number of years he served as Secretary of the Washington County Fair and he had been Secretary of the Nebraska Fair Managers Association for a long term. He had at one time been a member of the Nebraska State Fair board. He was an officer of the Arlington State Bank and at various times had served numerous other community posts.
