

2014: THE YEAR THAT WAS

2014 was a momentous year for the Danish American Archive and Library. We not only made decisions about finding a permanent home for the Archive, but also about our day-to-day operations, our relationships with other institutions, fundraising initiatives and outreach to the Danish American community at large.

Permanent Home. Probably the biggest issue we took on in 2014 was finding a permanent home for the DAAL. Although the DAAL has done remarkably well operating independently since leaving the safety net of Dana College in 2010, we know this success can't continue long term without developing closer ties with another organization. After considering the options available to us, the Board of Directors decided to accept the offer from the City of Blair and the Blair Public Library to become a part of the library's planned building project. Although this would not provide us with continuing support from the city, the mortgage payments on the proposed 40-year loan would be substantially less than our current the lease payments. Negotiations with the city are continuing in efforts to produce a firm agreement that is acceptable and possible for all parties concerned.

Day-to-Day Operations. Until now, Executive Director Jill Hennick has been the only paid staff member at the DAAL. Everything else that happened resulted from the efforts of volunteers. During 2014, we were able to include in the budget funds to hire two part-time staff members—Library Assistant Michael Hennick and Financial Assistant Kate Garrett. Michael's main focus has been on assisting Library Director Sharon Jensen with the tremendous job of sorting and cataloging the roughly 12,000 books in the collection. But more than that, at his own initiative, Michael has sorted and made right aspects of the Archive that have been overlooked since we were still at Dana College. He has made a huge difference to the overall operation of the DAAL. Kate Garrett started as a summer volunteer while she was still in high school and so impressed us with her efficiency and work ethic that we hired her as an accounting intern the summer of 2013 and as an accounting assistant last summer. Kate is now a freshman at The Ohio State University, but came in to work when she was home for Christmas break, and we hope to have her back this summer as well.

Relationships with Other Institutions. Because the community cooperation agreement with the University of Nebraska at Omaha (UNO) has been so successful, we have pursued similar agreements with other institutions with compatible missions. In 2013 we signed a similar agreement with Grand View University in Des Moines, Iowa, the sole remaining U.S. college founded by Danish immigrants, and with the Museum of Danish America (MoDA) located in Elk Horn, Iowa. The DAAL's relationship with UNO continues with student interns who provide invaluable service by cataloging previously untouched collections. The DAAL and MoDA jointly contracted with Paul Johnson as a planned giving consultant. In this capacity, Paul contacts donors of both the DAAL and MoDA to advise them on how to set up estate gifts.

Fundraising. Three fundraising projects are underway at the DAAL. First, our usual end-of-year appeal resulted in an unprecedented response. We are so grateful to all of you who have supported us with your contributions for so long. Second, Paul Johnson is making contacts regarding planned giving. It is our hope that these estate gifts will help build up an endowment fund that will support the DAAL in the future. The third fundraising project will be a capital campaign to raise funds for the possible new building. As an autonomous archive, we have to depend on charitable contributions, so these fundraising efforts are necessary for us to continue to thrive.

Outreach to the Danish American Community. We have redesigned the DAAL website to make it more user friendly and to include more information. It features better links to the digital archive, and we are constantly expanding the material accessible from it. Currently we are working on uploading scanned materials from the Dana Room, and those will be available soon. Another outreach tool for us continues to be the *Danish Children Growing Up American* exhibit. It is currently on display at MoDA until the end of June. From there it will travel to the Denver, Colorado, public library in October and will be on display there until the end of



December. This means attendees of the Danish Sisterhood national convention will have the opportunity to stop in and see it. In addition, we now host three volunteer weeks each year, organize a "Kringle Mingle" event for the annual Dana College homecoming, and both President Gary Madsen and Board Member Tim Jensen have addressed civic groups and other organizations regarding the DAAL.

We are very proud of the progress we have made in the last four and a half years, and thanks to your help and support, we are stronger than ever.

FROM THE DANA ROOM

A BRIEF HISTORY OF THE DANA FOLK DANCERS

For more than 40 years, the Dana Folk Dancers, accompanied by a student accordionist, entertained audiences with lively Danish peasant, ballroom, and game dances, such as the "Finger Polka," "Shoemaker" and "Oxen" dances, "The Dancing Cavalier," "The Crested Hen" and "Little Man in a Fix." In their Danish folk costumes, the Dancers – who were not necessarily of Danish descent – were colorful as well as lively.

Sandra Thomsen, a Dana junior

who started the group in late 1957, had danced with the Danish Folk Dancers of Omaha. She was treasurer of the Dana Chapter of The American Scandinavian Foundation, which initially sponsored the group – its president was Prof. Norman C. Bansen.

The student-directed Dana Folk Dancers became a popular group, and within two years they'd performed, for example, for high school audiences and at Omaha's Joslyn Art Museum, the Officers Club at Offutt Air Force Base and the national convention of the Danish Sisterhood of America.

They became even more widely known after a feature article titled "Square Dance a la Denmark: Dana Students Entertain in Colorful Costumes," appeared in the April 27, 1958, Sunday magazine of the "Omaha World-Herald." Director Thomsen and assistant director Larry Jorgensen in their costumes are pictured on the full-color cover.

When Dana celebrated its 75th anniversary the next year, the Dancers performed at the intermission of an Omaha Symphony Pops Concert at that city's then Peony Park and for campus visitor Carlo Christensen, Cultural Attaché of the Danish Embassy in Washington, D.C. In a subsequent letter to Dana President C.C. Madsen, he wrote, "One of the most beautiful experiences I have had during my stay in the United States was seeing the performance of the folk dancers of Dana College."

Over the coming decades the Dancers performed at local events, including Homecoming, Blair's Danish Days, and Dana's Sights and Sounds of Christmas. They also received invitations to perform, and so they traveled, in 1973, for example, to dance at the Milwaukee Folk Festival, sponsored by the International Institute of Milwaukee, and in Denver, Colorado, at a "Salute to Danes," sponsored by a local department store. Closer to home, in 1976 they danced in Omaha at a Lutheran Medical Center benefit ball, where actress Celeste Holm also appeared. And on campus that year, (Cont. Page 3)

they danced for Victor Borge before his first Dana benefit performance. Then in 1977, for the inauguration of President Jimmy Carter, seventeen Dancers, together with Phil Pagel, Director of Public Relations, went to Washington, D.C., as guests of Elmer Carlsen of Audubon, Iowa, where they performed twice nightly at Carlsen's "Farmers for Carter" parties. (The Duke Ellington and Tommy Dorsey orchestras played at these events.) While in Washington they also attended the inauguration, danced at the traditional Nebraska Congressional delegation's weekly breakfast, were photographed on the Capitol steps with Congressman John Cavanaugh of Nebraska and were guests at an informal reception at the Danish Embassy. They also appeared briefly on national television during NBC's "Today" show's coverage of inaugural events.

Another – and longer – TV appearance came in 1982, when they performed on Nebraska Educational Television, in the second part of a three-part series called "Hand-Me-Downs," hosted by author and folklorist Roger Welsch, a former Dana faculty member.

And over the years, Dancers who sang in the Dana College Choir often packed their costumes and performed during Choir tours in this country and in Denmark and Germany.

On campus, they refreshed their repertoire whenever members of touring Danish gymnastics teams that also featured folk dancing volunteered to critique their performance and teach them new dances.


By the late 1980s, however, student interest in the group waned, and the Folk Dancers are last pictured in the 1988 "Danian," the college yearbook.

But there was to be one more performance. For the 2001 Homecoming, Cheryl (Paulsen) Nielsen, a Dancer who graduated in 1968, organized a Dana Folk Dancers reunion, and former Dancers representing all four decades returned to dance once more.

THE LLOYD AND MURIEL NEVE COLLECTION

The Lloyd and Muriel Neve Collection, like several others at the Danish American Archive and Library, is primarily a collection of letters. Yet this collection stands out for the extraordinary depth and variety of its correspondence.

Lloyd and Muriel came from different, yet complementary, backgrounds. Lloyd was a pastor's son, born in 1923 in the small, rural community of Beresford, South Dakota, and raised in a devout, highly intellectual, Danish Lutheran family. Muriel was born in 1924 in San Jose, California, and adopted into a Methodist family in Oakland. She, like Lloyd, pursued both undergraduate and graduate studies in religion. In the late 1940's their paths crossed in Japan, where they had become Christian missionaries. They soon married and began what became a four decade joint missionary career.

Their six children were all born during this period. Although they "retired" from Japan to Blair, Nebraska in 1988, the pace of their lives did not slacken. Muriel won awards for her flower garden, and for many years they devoted the winter months to volunteering for Bread for the World in Washington, D.C. Betwixt and between, they traveled extensively, living and working in both Latin American and African countries

Through these years and beyond they maintained a prolific and insightful correspondence, first with friends and supporters in Japan and the States, and later with their six energetic and articulate children. During their frequent travels they kept detailed and insightful diaries, which now serve as fascinating

supplements to their correspondence.

Their letters and narratives reveal Christian concerns, a wide range of intellectual interests, an extensive network of friends, relatives, and supporters, and intense intra-familial relationships. To read their letters is to learn not only about life in Japan, but about everything from American football and politics, to music, jewelry making, genetics, cooking, human emotions, and books recently read. The letters of some of their children reveal in vivid detail the joys and the difficulties, the rivalries and the friendships, of life as graduate students in American universities.

Rounding out this extraordinary collection are books that Lloyd has written, information on other missionaries, and many photographs. Now in their 90's, they continue to live at Johansen Manor in Blair.



DIGITAL ARCHIVE: A WORK IN PROGRESS

Providing researchers and scholars an easier way to access the extraordinary materials contained in the DAAL collections has long been one of our goals. And two years ago volunteer Matt Petersen of Des Moines, Iowa, began to make that goal a reality when he created the Digital Archive, which can be accessed from the DAAL website.

The first collection to appear in the Digital Archive was the P.S. Vig Family collection, a rich collection of letters, papers, clippings, documents, pictures, scrapbooks, notes, obituaries and family records for people who settled in or were buried in Washington County, Nebraska, from the mid-1800s into the 1970s. Next came the P.C. Jensen collection--letters, sermons, memorabilia, and records of all UELC pastors kept by this former pastor and historian of the UELC. one of two Lutheran synods founded by early Danish Americans. Both of these collections provide a goldmine of information for genealogists and researchers. Back issues of Jottings were initially posted on the Digital Archive, but were moved to the recently redesigned main website.



Currently we are working on posting materials from our monumental Dana College collection. This collection requires hours of sorting and evaluating which documents will be most useful. Our thanks to volunteer Aaron Loyd for his dedication in scanning many of these materials. With Dana College files ranging from the 1800's to 2010 and containing everything from news releases to yearbooks to minutes of

Board of Regent meetings along with thousands of photographs, we would welcome more help with sifting through or scanning these materials. Some of this work can be done remotely and we can train you.
