Sibbernsen, Conservation Pioneer, Dies

Albert H. Sibbernsen, 74, a pioneer soil conservationist in Nebraska, died at his farm home near Bennington about noon Fri-

day. 3-21 Death came after a short illness.

He was a graduate of Dartmouth College and a flight instructor in the U.S. Army Flying Corps of World War I.

In 1925, he bought 800 acres of gullied farm land north of Elk City, Neb., and built it up with terraces, grass waterways, contours and brush dams. Despite severe drouth years, he hung on, practiced every new soil-saving technique he could learn of and developed several of his own.

Land Thrived

The land thrived under his care and attracted nationwide attention.

Sibbernsen was a member of the Washington County Farm Bureau, supervisor of the Wash-

ington County Soil Conservation 1 District and secretary of the Papio Watershed Committee.

In June of 1962 he was elected president of the Fort Atkinson Foundation which was instrumental in raising funds and purchasing the historic site and turning it over to the state for development as a park.

He was a candidate for the north district of the Omaha Pubilic Power District in 1956 and for more than 18 years served as a board member of the Union Stock Yards Co. Golden Anniversary He retired from the stockyards post last month. Mr. and Mrs. Sibbernsen observed their golden wedding anniversary last December 27. Sibbernsen is survived by his widow, Grace Allison, and two sons Albert A. and David and 10 grandchildren.
