Commissioner And Road Superintendent/ For 23 Years

Clarence Kuhr, well known Blair man and a lifelong resident of Washington County, died Tuesday at Memorial Community Hospital in Blair. He had been hospitalized for several weeks following heart complications and several paralytic strokes. He was 66 years old.

Mr. Kuhr had served Washington County for 23 years as a County Commissioner and later as Superintendent of Roads.

He was born at Kennard February 5th, 1904 and he grew up to manhood in the Kennard vicinity. On June 17, 1929 he was married to Miss Edna Beck, of Blair and the couple farmed in the Orum vicinity for 8 years.

Later he moved to Blair and became interested in the oil business, both retail and tankwagon distribution throughout the Blair

He became a candidate for County Commissioner during the time that this county was governed by a three-commissioner system. Later, he resigned the post to accept the position of County Highway Superintendent, which office he headed until the time of his death. As road superintendent, he built an effective maintenance system with road men stationed throughout the county to provide the most effective and the quickest service when needed. He also di-
