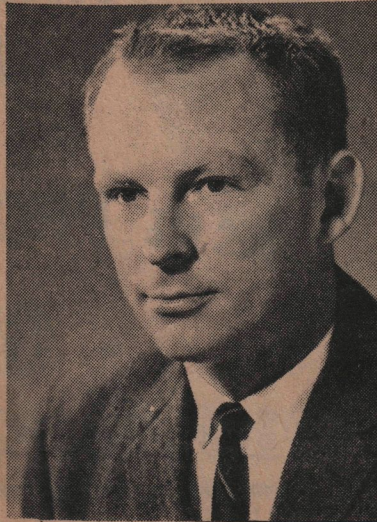


### DR. RICHARD JENSEN, FORMER BLAIR MAN, DIED IN COLORADO

Dr. Richard L. Jensen, a former area resident and son of Mr. and Mrs. James G. Jensen of rural

Blair, Nebraska, was stricken suddenly at his home in Longmont, Colorado, by a cerebral hemorrhage and died shortly after in a Denver hospital at the age of 38. Dr. Jensen was born and reared in the Blair area. He was a 1948 graduate of Blair High School and a 1952 graduate of Dana College. He worked for one year with the Atomic Energy Commission in Ames, Iowa. He then completed training at the Officers Candidate School in Newport, Rhode Island and served four years as a naval officer, before attending Northwestern University School of Dentistry in Chicago, Illinois. Since that time, Dr. Jensen has practiced dentistry in Longmont, Colorado.

Dr. Jensen is survived by his wife, Sandra; three daughters, Jami, 8; Amy, 7; Marci, 2; one son, John, 5; his parents; and his brothers and sisters, Mrs. Vernon Bellows (Phyllis) of Omaha; James R. of Bridgeport, Nebraska; Ray G. of Blair; and Mrs. Jeffrey Vinton (Kathy) of Omaha.

### FORMER BLAIR MAN DIED RECENTLY AT DODGE CITY, KANS.

Funeral services were held Wednesday for James Woltje, a one-time Blair man, who died recently at Dodge City, Kansas. Woltje, who was 63 years old, was a laborer, doing construction work. He was not married.

Mr. Woltje was born at Anthony, Kansas July 9, 1906 and was the son of the late Mr. and Mrs. Fred Woltje. The family, for many years, lived at 335 South 16th St. just north of the Congregational

Church. Mr. Woltje, will be remembered as a custodian in the Blair schools.

Funeral services were held at the Campbell Mortuary Wednesday afternoon with the Rev. Richard Atherton conducting the service. Burial was made in the Blair cemetery.

The deceased is survived by a brother, Eddie Woltje, of Norfolk, Nebraska and by three sisters, Miss Nellie Woltje of Blair; Mrs. Caryl Brown, of Omaha and Mrs. Ralph Johnson, of Los Gatos, California.
